**Note:** PLEASE plan to arrive promptly at the beginning of the ORT. We will have one Judge's briefing at the beginning of the evening. We are not supplying a pre-assigned running order. The running order will be posted on a white board at the start time of each ORT. You can leave when your dog(s) has completed his/her ORT. If you are running two dogs, keep in mind that all dogs and handlers will run one dog, then any handlers with a second dog will run at the end.

**Test Site Information**

There will be NO indoor crating available. Dogs must be securely crated in a vehicle. All dogs must be on a 6' leash at all times when not being tested. No flexi-leashes for walking dogs on test site grounds; flexis may be used in the test itself. Please observe the designated potty areas and waste disposal sites.

**Entry Requirements**

The handler of the dog must be a current member of the NACSW™. The Dog must be registered with the NACSW™. For information on how to register or become a member go to [www.NACSW.net](http://www.NACSW.net)

**Entry Fee and Second Dog Policy**

\$30 per dog per odor.  
We will allow up to two dogs per handler.

**Closing Date**

The ORT will close when limits are met. We will take approximately 25 ORTs per odor. Overnight mail entries must have the signature request waived.

**Refund Policy**

Refunds minus a \$10 administration fee will be granted before January 1<sup>st</sup>. After the 1<sup>st</sup>, refunds will only be granted due to documented medical causes (documented by a vet). **ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, or excused by the NACSW™ official or judge.

**Video/Photography Policy**

ORT participants are allowed to have a friend or family member video/photograph their test. ORT participants are not allowed to video/photograph one another. ORT hosts are not obligated to provide someone to video/photograph.

## **DIRECTIONS**

### **From Atlanta on I-20W**

Take the GA-5 exit, EXIT 34, toward Douglasville.  
Keep left to take the GA-5 S ramp toward Whitesburg.  
Turn left onto GA-5 S/Bill Arp Rd. go back across the interstate and travel 0.3 miles  
Turn right onto Douglas Blvd go 0.9 miles  
Turn right onto Bright Star Rd go 0.5 miles  
Douglasville 7<sup>th</sup> Day Adventist School is on the right.

### **From Alabama on I-20E**

Take EXIT 34 and merge onto GA-5 S/Bill Arp Rd  
Turn right onto Douglas Blvd go 0.9 miles  
Turn right onto Bright Star Rd go 0.5 miles  
Douglasville 7<sup>th</sup> Day Adventist School is on the right.

### **From GA Hwy 92 S**

Turn right onto Broad St/US-78/GA-8/GA-5. Continue to follow US-78/GA-8 for 1.9 miles  
Turn left onto Bright Star Rd. go 1.0 miles.  
Douglasville 7<sup>th</sup> Day Adventist School is on the left

### **From GA-5N/Bill Arp Rd.**

Turn left onto Bright Star Rd. go 2.4 miles  
Douglasville 7<sup>th</sup> Day Adventist School is on the right.

## **TEST Information - Notice to Exhibitors**

**THE TEST SITE** will be open from 5:00 – 9:30 PM

**CHECK-IN: 5:30 – 6:00 PM**

**HANDLER BRIEFING: 6:00 PM**

**Exhibitors may bring their dog's SCOREBOOK with them to the test. Results are recorded in the SCOREBOOK. The SCOREBOOK is not necessary to take the ORT.**

**NO SPECTATORS ARE PERMITTED IN THE SEARCH AREA** during the ORT except NACSW™ officials, adults accompanying a minor, CNWI-in-training, or immediate family members/friends of the dog/handler team currently being tested.

### **ENTRIES:**

- TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted.
- RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.
- ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM.
- NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.
- OWNERS are responsible for errors in making out entry forms.
- EXPRESS MAIL entries must include signature permitting them to be left at the secretary's address without recipient's signature.

**DOGS PRESENT** will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged. Be prepared to keep your dog in your car when not being tested or on leash at all times. There is no inside crating at this test.

**DOGS PARTICIPATING** in ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

Acknowledgement of entry acceptance/CONFIRMATION will be made when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.

**BASIC DESCRIPTION OF TEST** – to successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an “alert” within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of one or two rows, spaced a minimum of 48” apart. The ORT is conducted on leash.
